This special award is presented to an individual who, through a long career in the forest industry (harvesting or manufacturing operations) has demonstrated an unwavering commitment to improving safety awareness, expanding safety knowledge, developing safety skills at ground level and building a lasting culture of safety among BC's forest workers.

This individual is known for being a "teacher" of safety, a trainer, an instructor, a mentor – someone who goes the extra mile to help others reach their safety goals with a helping hand, proven experience and knowledge.

### Forest Safety Most Valuable Player (M.V.P.) (Harvesting or Manufacturing)

This award recognizes an individual or group that has made a notable contribution to forest industry safety within their operation or company.

The M.V.P. (in harvesting or manufacturing operations) could be:

A worker whose idea resulted in improvements to workplace safety; a supervisor who communicated regularly with his crew and spearheaded safe work procedures; a crew that found a new way to work more safely and productively; a manager who demonstrated a commitment to worker safety through his/her actions; a committee that achieved safety improvements at work through persistent efforts to seek changes, or a company that has demonstrated leadership in integrating health & safety into their business practices.
